Terms of payment

ExpoStart will be invoiced at confirmation.
20% of the stand rental is to be paid 180 days, and the balance 60 days before the opening of the exhibition.
Technical services are to be paid 14 days before the opening of the exhibition. Invoices will be sent out 30 days before the due date and must be settled by the stipulated date. A monthly interest rate of 2% will be charged after due date.
ExpoStart and stand rental are non-refundable fees, in case of cancellation. VAT will be levied in accordance with Swedish tax legislation.

VAT-registration
